Paragraph 14 of the NPPF states that at the heart of the NPPF is a presumption in favour of sustainable development. For plan-making this means that local planning authorities should positively seek opportunities to meet the development needs of their area; and that the Local Plan should meet the objectively assessed housing need, with sufficient flexibility to adapt to rapid change. This is furthered at paragraph 157 which states that crucially, Local Plans should positively plan for the development and infrastructure required in the area to meet the objectives, principles and policies of the NPPF.

Policy 12 sets out the sites allocated for housing and/or housing led development, including which sites will contribute to the Borough's 5 year housing supply. The evidence base for the housing policies set out within the Borough's Part 2 Plan does not evidence the availability, suitability, and achievability of the sites listed in policy 12. Therefore, as per paragraph 47, footnote 11, the sites cannot be considered deliverable, and should not be included in the Boroughs five year housing supply. Therefore, policy 12 does not accord with policy 47 of the NPPF, which requires local planning authorities to provide a five year housing supply against their housing requirement.

Subsequently, paragraph 49 dictates that relevant policies to the supply of housing cannot be considered up to date as the Borough cannot demonstrate a five year supply of deliverable housing sites. Therefore, the Borough cannot meet the development needs of their area, in direct contrast with paragraph 14 and the presumption in favour of sustainable development.

It is considered that Policy 12 is not positively prepared as it does not meet the development needs of the Plan, it is not justified as it is not based on proportionate evidence, and it is not consistent with national policy as it does not enable the delivery of sustainable development.

In order for the policy to be positively prepared, justified and consistent with national policy, the Borough should look to allocate further sites that can provide considerable evidence to demonstrate their availability, suitability, and achievability to confirm that they can deliver.
