West Northamptonshire Council submitted the Northampton Local Plan Part 2 to the Secretary of State in February 2021 for independent examination. Examination Hearings were held by the Planning Inspectors Philip Lewis BA (Hons) MA MRTPI and Mark Sturgess BSc (Hons) MBA MRTPI in November 2021.

Following the Hearings, a number of Main Modifications have been prepared at the request of the Planning Inspectors. A Main Modification is an amendment which is considered necessary to make the Plan sound and is required in order to address concerns raised by the Inspectors or other representors during the examination process. The Council has prepared a schedule setting out the proposed Main Modifications it considers necessary in order for the Local Plan to be found sound. They are put forward without prejudice to the Inspectors' final conclusions and all representations will be taken into account by the Inspectors. The Main Modifications have been subject to Sustainability Appraisal and Habitats Regulations Assessment. Representations about the Main Modifications, Sustainability Appraisal and Habitats Regulations Assessment will be forwarded to the Inspectors.

The Council is also consulting on Additional Modifications which are minor changes that do not relate to the Plan's soundness. The Main Modifications and Additional Modifications have also resulted in the need for a number of consequential changes to the Policies Map. The Council is consulting on these changes too. The Inspectors will not be considering responses to consultation on Additional Modifications or

Policies Map Changes in their report and recommendations; these will be matters for the Council to consider.

PERIOD FOR MAKING REPRESENTATIONS

The consultation runs for six weeks from Thursday 7 July to 23:59 on 18 August 2022.
