

CLEAN AIR ACTS, 1956 AND 1968

The County Borough of Northampton (No.6)

Smoke Control Order 1972

1. Notice is hereby given that the Council of the County Borough of Northampton in exercise of the powers conferred on them by Section 11 of the Clean Air Act, 1956, on the Seventh day of January, 1972 made an Order entitled the County Borough of Northampton (No.6) Smoke Control Order, 1972, declaring the area described in the schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.
2. Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the 1956 Act if, on any day after the Order has come into operation, smoke is emitted from any chimney of any building within the Smoke Control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite coke and other carbonised fuels, gas and electricity.
3. Further if on any day after the Order has come into operation any person buys or acquires any unauthorised fuel intending it to be used in a building in the area not being an exempted building or in a boiler or plant in the area not exempted under the said Section 11, or delivers unauthorised solid fuel to a building in the area not being an exempted building, he shall be guilty of an offence under Section 9 of the Clean Air Act, 1968, and liable to a fine not exceeding £20 unless he proves that he believed that the building was exempted or that the fuel was acquired for use in a fireplace boiler or plant so exempted.
4. Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Clerk's Office, Newilton House, Derngate, Northampton, at all reasonable times during the period of six weeks from the Eighteenth day of January, 1972.
5. Within the said period any person who will be affected by the Order may by Notice in writing to The Secretary, Department of the Environment, Whitehall, London S.W.1. object to the confirmation of the Order.

SCHEDULE

AN area bounded on the north by the Weedon Road from the boundary of the County Borough to the Western perimeter of Weedon Road Industrial Estate then south to the River Nene and along the line of the river to its junction with the railway line then south to the rear of properties in Rothersthorpe Avenue and east along the south side of Rothersthorpe Road to the eastern perimeter of the allotment gardens then south to the rear of properties on the west side of Towcester Road to its junction with Mereway then east along the north side of Mereway to its junction with London Road then north along the east side of London Road to the rear of properties on the south side of Southfield Avenue then east along the Northern perimeter of Delapre Park to the railway bridge. The eastern southern and western boundaries then follow the County Borough boundary to the Weedon Road.
