The Council of the County Borough of Northampton in exercise of the powers conferred upon them by Section 11 of the Clean Air Act, 1956, hereby make the following Order:

1. This Order may be cited as the County Borough of Northampton (No.1) Smoke Control Order, 1969
2. The area which is coloured green on the map prepared in duplicate sealed with the common seal of the said Council of the County Borough of Northampton and marked "Map referred to in the County Borough of Northampton (No.1) Smoke Control Order, 1969" is hereby declared to be a smoke control area. One duplicate of the map is deposited in the offices of the said Council of the County Borough of Northampton and the other is deposited in the offices of the Minister of Housing and Local Government
3. The buildings in the area which are specified in the Schedule hereto shall be exempted from the operation of the said Section 11
4. This Order shall come into operation on 1st <sup>September</sup> ~~June~~ 1970

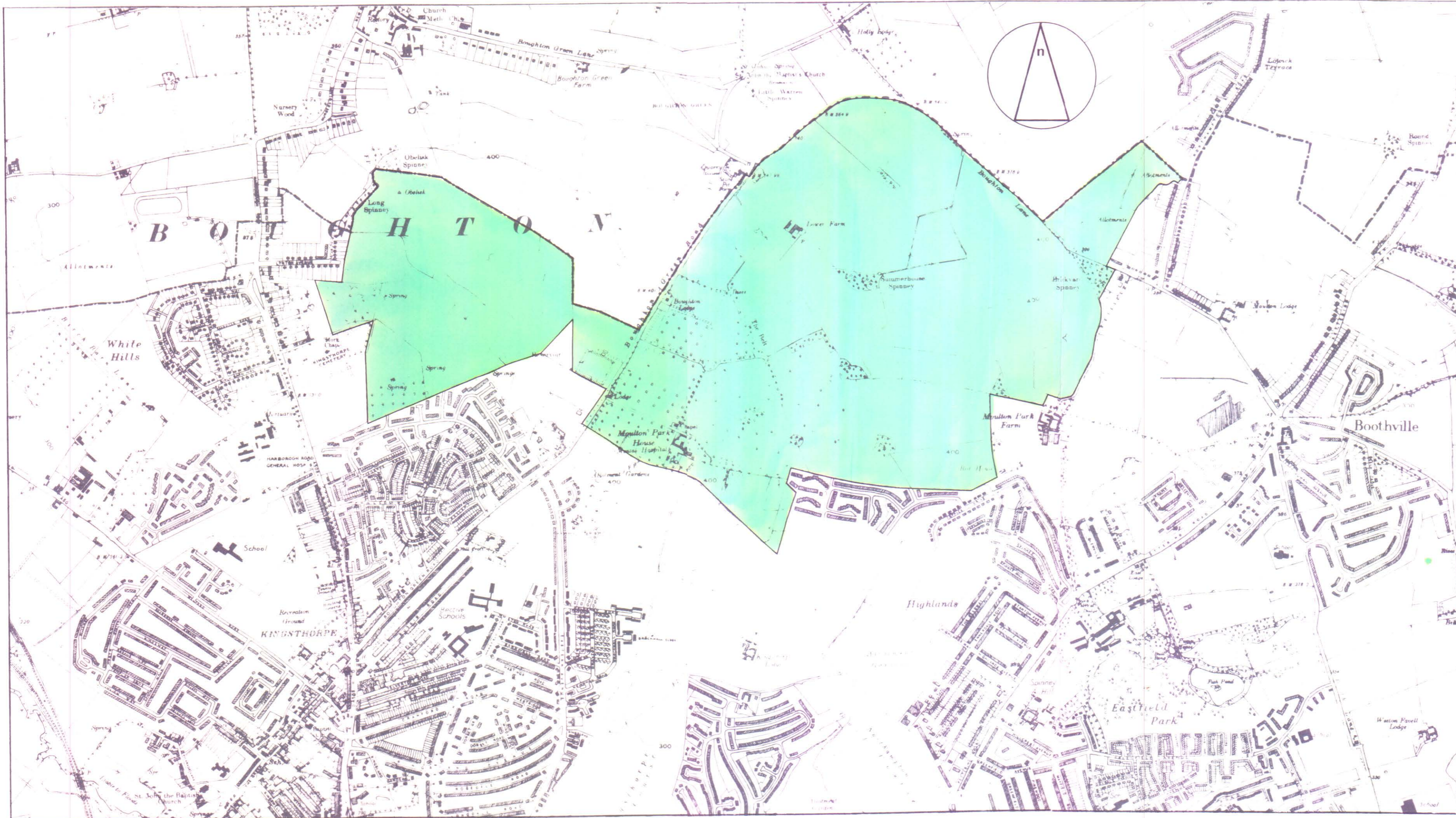

The Council of the County Borough of Northampton in exercise of the powers conferred upon them by Section 11 of the Clean Air Act, 1956, hereby make the following Order:

1. This Order may be cited as the County Borough of Northampton (No. 1) Smoke Control Order, 1969
2. The area which is coloured green on the map prepared in duplicate sealed with the common seal of the said Council of the County Borough of Northampton and marked "Map referred to in the County Borough of Northampton (No. 1) Smoke Control Order, 1969" is hereby declared to be a smoke control area. One duplicate of the map is deposited in the offices of the said Council of the County Borough of Northampton and the other is deposited in the offices of the Minister of Housing and Local Government
3. The buildings in the area which are specified in the Schedule hereto shall be exempted from the operation of the said Section 11.
4. This Order shall come into operation on 1st September, 1970.
