THE CLEAN AIR ACTS 1956 ~~AND 1968~~

THE NORTHAMPTON BOROUGH COUNCIL (THE COUNTY  
BOROUGH OF NORTHAMPTON (NO.2) SMOKE CONTROL  
ORDER 1969) VARIATION ORDER 1975

WHEREAS on the 25th day of July 1969 the Council of the <sup>County</sup> Borough  
of Northampton in exercise of the powers conferred upon them by  
Section 11 of the Clean Air Act 1956 made an order called "The  
County Borough of Northampton (No.2) Smoke Control Order 1969"  
(hereinafter called "the Principal Order") declaring the area  
mentioned therein to be a smoke control area which said Order  
was confirmed without modification by the Minister of Housing  
and Local Government on the 25th day of February 1970

AND WHEREAS by virtue of the Local Government Act 1972 the  
powers conferred upon the County Borough of Northampton by Section  
11 of the Clean Air Act 1956 were transferred to the Northampton  
Borough Council (hereinafter called "the Council")

AND WHEREAS the Council have resolved to vary the Principal  
Order in the manner hereinafter appearing

NOW THEREFORE the Council in exercise of the powers conferred  
on them by Section 11 of the Clean Air Act 1956 hereby make the  
following Order:-

1. This Order may be cited as <sup>"</sup>The Northampton Borough Council  
(The County Borough of Northampton (No.2) Smoke Control  
Order 1969) Variation Order 1975."

2. The Principal Order shall be varied as follows:-

The buildings in the said area which are specified in the  
Schedule to this Order shall cease to be exempt from the  
operation of the said Section 11.

3. This Order shall come into operation on the 1st day of November  
1976.
